CORRIGENDUM

Sub :- In e-tender dated 02/09/2019 for hiring of Taxi to DDK Guwahati, the following amendments to be incorporated reg.

With reference to above cited subject of this office e-Tender No.48(2)/H/2019-20 dated 02/09/2019 for hiring of Taxis to DDK Guwahati, the following clause has been modified as mentioned below.

- 1) It is proposed to have one more pre-bid meeting on 23.09.2019 at 1500Hrs. Those who already attended Pre-Bid meeting on 18.09.2019 need not attend. Also, the clause "Attendance of Pre-Bid meeting is Mandatory" is withdrawn.
- 2) Clause 28 in General terms and condition for hiring of vehicles to Doordarshan Kendra Guwahati on Annual contract basis, kindly read the lines **Technical bid will be considered only of those tenderers who have submitted the required E.M.D. Instead of Technical bid will be considered only of those tenderers who have submitted the required E.M.D. and attended pre bid meeting.**
- 3) clause 1 in General terms and condition for hiring of vehicles to Doordarshan Kendra Guwahati on Annual contract basis is modified as

1. The Supplier/Contractor should have under his ownership and possession, a minimum number of the following vehicles mentioned below, which are not more than four years old ie., Models of 10/2015 or later registered with the appropriate Transport Authority.

- 4) Clause 27 in General terms and condition for hiring of vehicles to Doordarshan Kendra Guwahati on Annual contract basis, the following clause is added/ Appended. **Those agencies registered with MSME/NSIC are exempted from submission of EMD and necessary copy in support of the claim for exemption of EMD shall be submitted along with the Technical Bid and a post copy may be sent to this office.**
- 5) Clause 28(i) in General terms and condition for hiring of vehicles to Doordarshan Kendra Guwahati on Annual contract basis is amended as **E.M.D.:- As per clause 28 of this tender document, E.M.D. should be submitted to this office before opening of Technical bid. Those agencies registered with MSME/NSIC are exempted from submission of EMD and necessary copy in support of the claim for exemption of EMD shall be submitted along with the Technical Bid and a post copy may be sent to this office.**
- 6) Clause 28(ii)(e) in General terms and condition for hiring of vehicles to Doordarshan Kendra Guwahati on Annual contract basis is amended as **Scanned copy of latest Income Tax remittances by the firm/agency made for the past three years. Instead of Scanned copy of latest Income Tax remittances by the firm/agency made for the past four years.**
- 7) The revised/corrected price bid is uploaded with below mentioned modification.
 - i) **A column will be added as 8hrs. 80 KM and 3Hrs.25Km. category shall be withdrawn.**
 - ii) **Adding column as out station charges per day and remove the column Minimum KM per day on out station.**
 - iii) **Adding Swift dezire in Airport Pickup/Drop category**

Only the Revised commercial bid/ price bid as mentioned in the Corrigendum shall be entertained.
