The above financial up-gradation under MACP Scheme shall be purely personal to the employee and shall have no relevance to his seniority position. As such, there shall be no additional financial up-gradation for the senior employees on the ground that the junior employee in the grade has got higher pay/grade pay under the MACP Scheme.

The above financial up-gradation under the MACP Scheme shall be conditional to the fact that an employee while accepting the said benefit shall be deemed to have given his unqualified acceptance for regular promotion on occurrence of vacancy subsequently, he shall not be eligible to be considered for further financial up-gradation till he agrees to be considered for promotion again and the next financial up-gradation shall also be deferred to the extent of period of debarment due to the refusal.

With regard to fixation of pay on grant of financial upgradation under the MACP Scheme, the employee concerned is required to exercise an option under FR-22(I)(a)(I) to have his pay fixed in the higher grade pay, either from the date of his up-gradatin or from the date of his next increment viz. 1st July of the year, within one month from the date of issue of this order.

Before implementing this order, it shall be ensured by the concerned Head of Office that no vigilance or Disciplinary proceedings are pending against the beneficiary and his integrity is found to be beyond doubt as on or before the effective date of MACP

The above up-gradation is subject to post check & audit observation(if any). In the event of any excess payment made to the employee concerned, the same would be recovered on lump sum without assigning any reason/notice.
